



The SaNa (Sachkunde Nachweis, certificate of competence) is required to purchase a fishing license valid for more than 1 month in any Swiss canton.

**NEW PROCEDURE FROM January 6, 2025**

Below are the steps involved in obtaining the SaNa, including on the three required payments for the course instruction manual, administrative fee and the course instruction fee.

## STEP 1

**PURCHASE OF THE COURSE INSTRUCTION MANUAL « Brevet suisse de pêche sportive » in French or « Schweizer Sportfischer Brevet » in German** (there is no manual in English)

The manual is available in **printed** or **digital PDF** format. It can be ordered online from PETRI HEIL magazine. **Internet site** : [www.petri-heil.ch/fr/home/brevet/uebersicht](http://www.petri-heil.ch/fr/home/brevet/uebersicht)

You may also purchase the instruction manual by calling PETRI HEIL at 055 450 50 60

The **printed** manual costs CHF 43.00 (CHF 39.00 + postage: CHF 4.00) or CHF 39.00 in **digital PDF format**.

When you purchase the manual, you will receive an **instruction manual code** which you will need to enter when you register for the SaNa course (see **STEP 2 below**).

➡ It is important to study the manual carefully **before** the course.

## STEP 2

**REGISTRATION TO A SaNa COURSE IN GENEVA**

You need to register for a SaNa course and exam.

You may register online at : [www.formation-pecheurs.ch/](http://www.formation-pecheurs.ch/)

On the home page, click on the tab: COURS SANA => Cours Standard => then scroll down to the canton of GENEVA

- Choose the course in English (normally 1 course in spring - 1 course in late autumn). During the registration process, you will be required to enter the **instruction manual code** that you received when you purchased the course instruction manual.
- Enter your personal data and pay the **administrative fee** of **CHF 30.00** to the Fishermen's Training Network.
- Once payment has been made, your registration will be validated and you receive by e-mail an inactive **SaNa number** which will be activated automatically if you pass the exam at the end of the course.

You may also register by phone, if you don't have Internet access. Call the Fishermen's Training Network on **022 318 28 01**. The **Network** personnel will be able to assist you with the registration procedure.

## STEP 3

**PAYMENT OF SaNa COURSE INSTRUCTION FEE IN GENEVA**

You must additionally pay a course instruction fee of **CHF 40.00** to : MOLL Jean-Pierre - Formation SaNa Pêcheurs Genève - Compte IBAN: CH62 0900 0000 1258 0444 1

This is different and in addition to the course registration fee mentioned in step 2, above.

Payment of the course instruction fee must be made no later than 10 working days before the start of the course for which you have registered. If payment is not made within this time, your registration will be cancelled, and your place may be allocated to another person.

## STEP 4

At the beginning of the course, please **show your ID** to the instructor and check that your personal data is correct
